Key Responsibilities

- Develop and maintain financial models for projects under development, acquisition, or refinancing, including sensitivity analysis.
- Perform economic and financial evaluations of acquisition and investment opportunities, including adaptation of third-party financial models.
- Assist in due diligence processes related to financing transactions or project acquisitions, coordinating with technical, development, and legal teams.
- Support the structuring and execution of financing and refinancing transactions, including assistance with lender negotiations and document review.
- Assist in the preparation of bids, proposals, and RFP responses, ensuring alignment with business and financial objectives.
- Support loan administration activities for project financing agreements, including updates to existing financial models.
- Research and summarize federal and state renewable energy incentive programs to identify new business opportunities.
- Prepare presentations, proposals, and reports (Excel, Word, PowerPoint) for senior management, external stakeholders, and investment committees.
- Maintain data rooms, reports, and documentation to support transaction management and audit readiness.
- Collaborate across departments to support business operations and ad-hoc strategic initiatives.
- Perform other financial and administrative duties as required to support the finance and business development teams.
